**REGISTRATION, CONFIRMATION & CANCELLATION**

Registration will only be confirmed upon full payment of registration fees. Deadline for pre-event registration is **14 August 2009**. Should registration and / or payment be received thereafter, you will receive your confirmation documents upon arrival at the Meeting in Amsterdam. On-site registration is possible throughout the duration of *The EMBO Meeting* but only whilst the registration counters are open.  
 In case of cancellation of participation until **27 May 2009**, registration fees will be refunded deducting an €18.00 handling fee per person. After that date, no further refunds will be issued. Name changes are subject to an €18.00 processing fee per registration. Should participants have any special requests with regard to invoicing, they should kindly let us know when returning the registration form. A processing fee of €20.00 will be charged if an invoice needs to be re-issued. All prices and details are correct at the time of publishing and are subject to change.

**LEGAL CONDITIONS**
